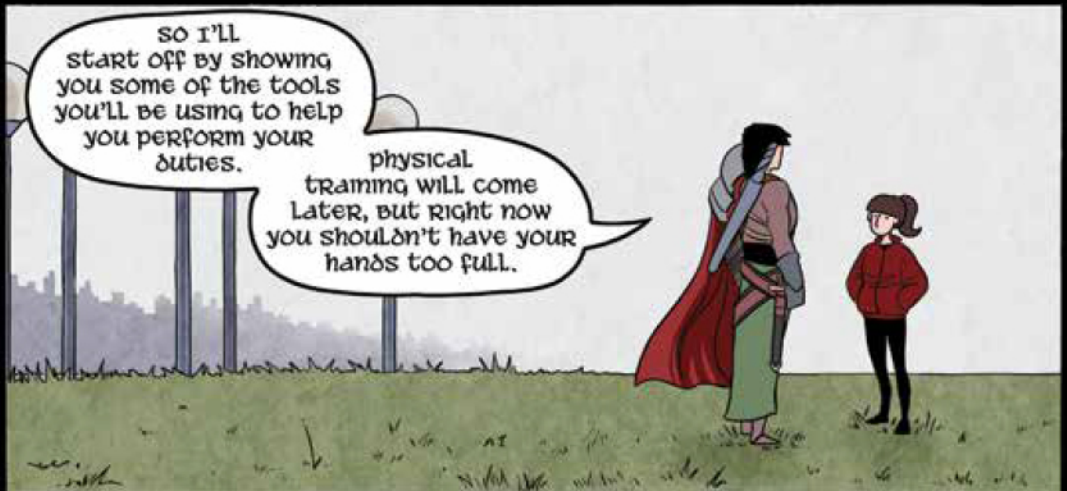

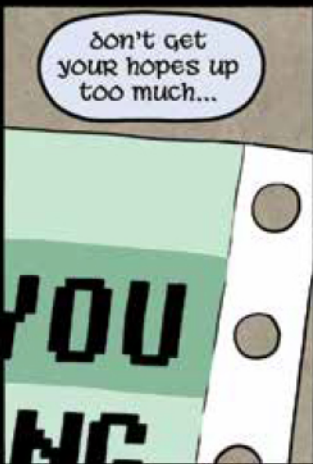
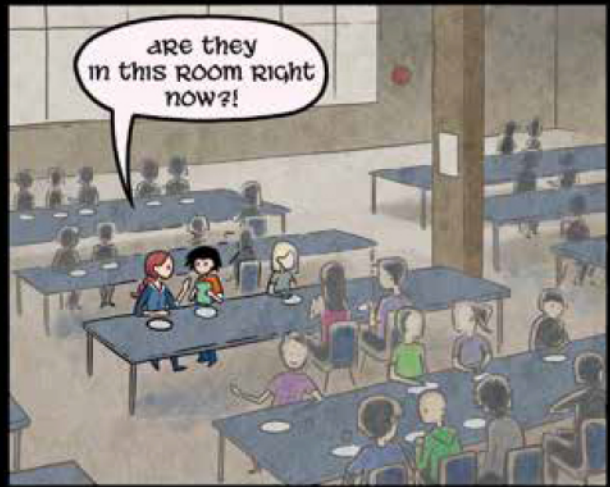

we're not intending to run in to him today. or coyote.



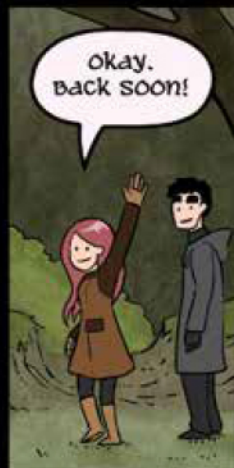
and with andrew around, luck should be in our favour!

friendly!

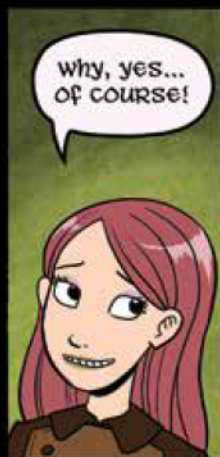
