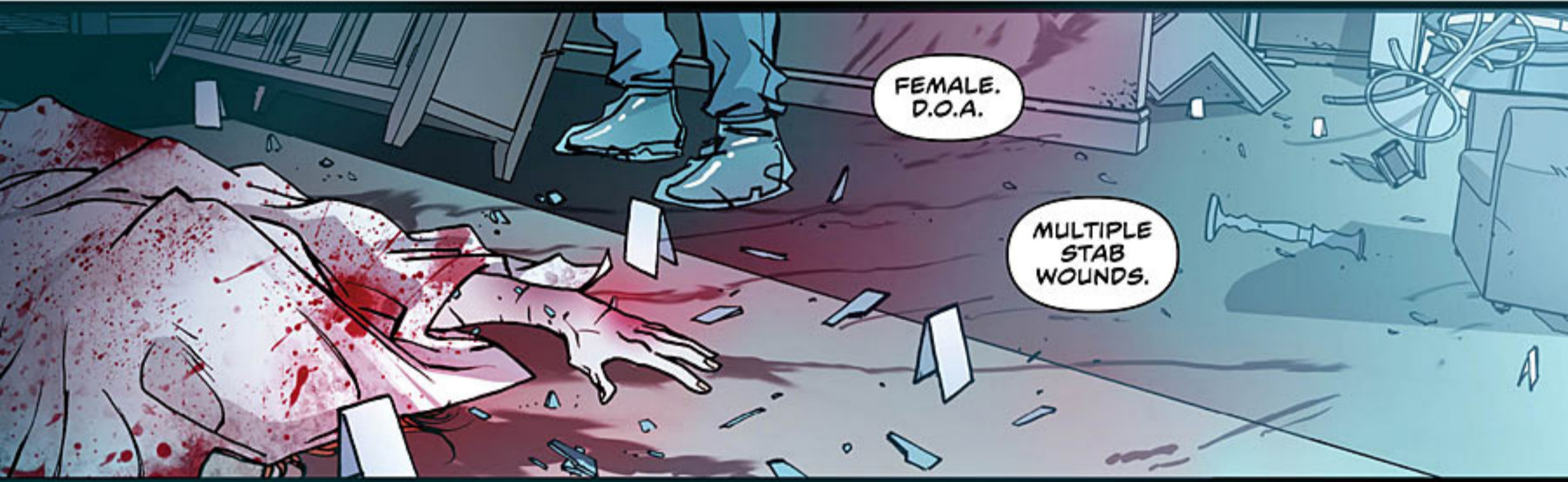

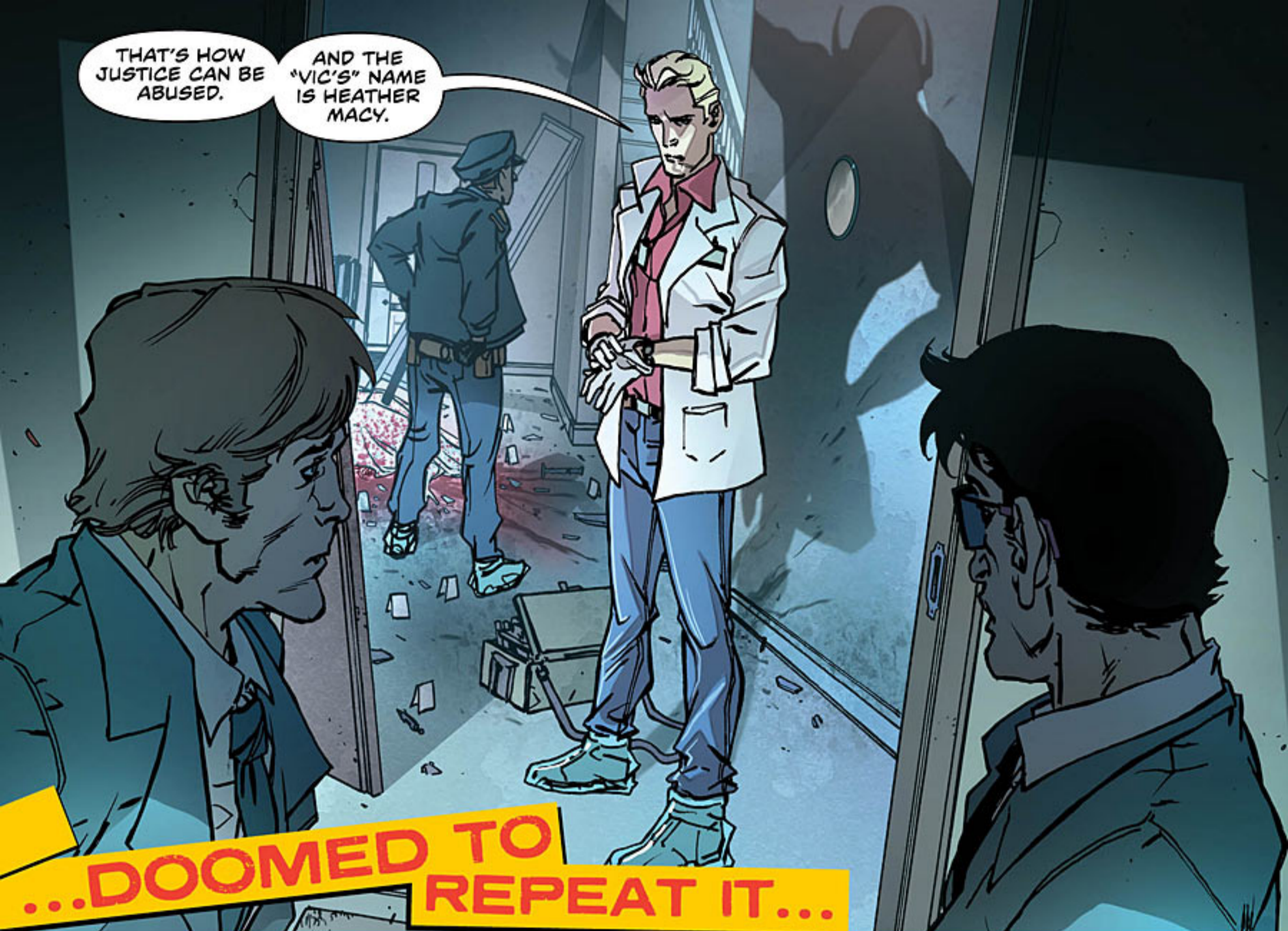

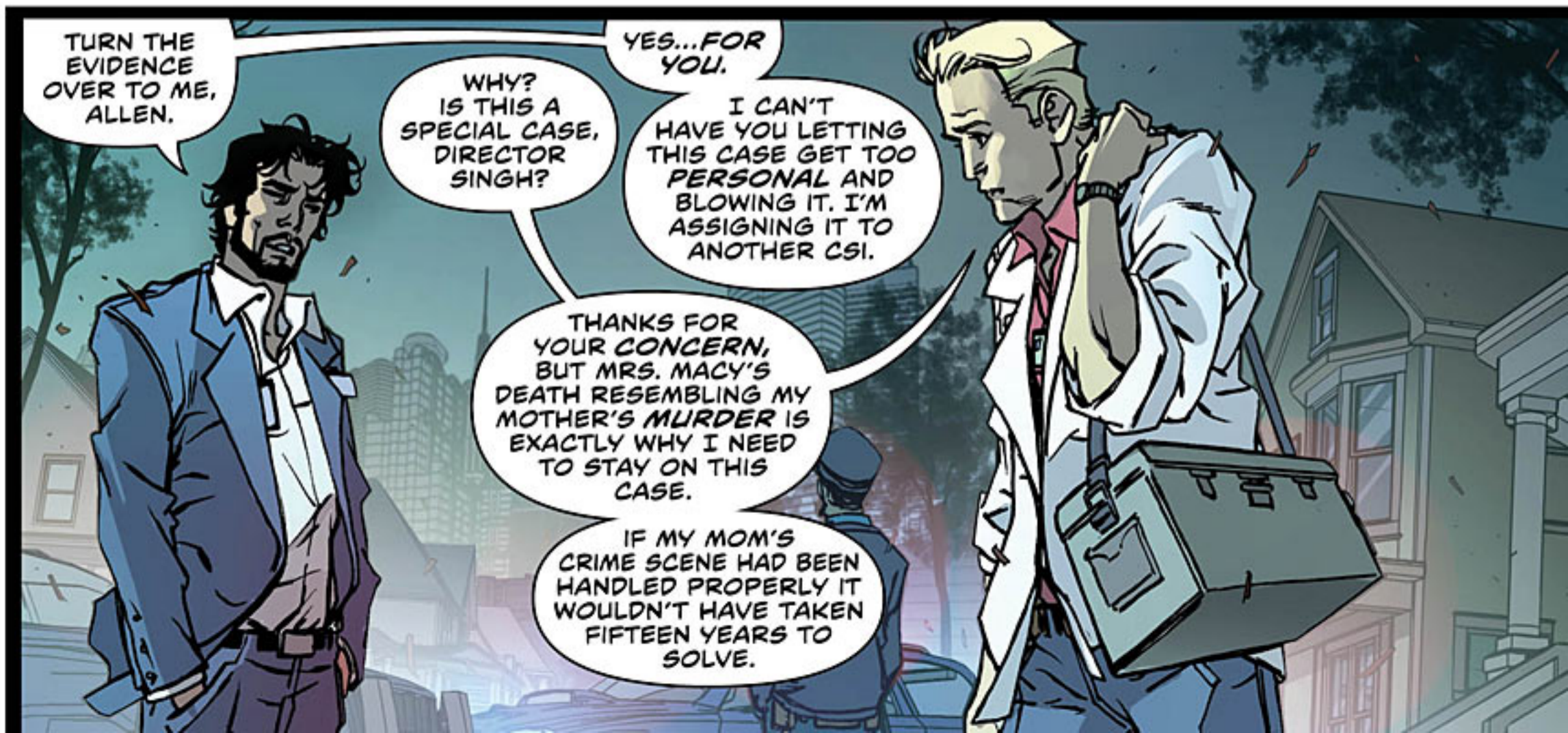


AW DANG, BARRY. YOU KNOW WE DIDN'T MEAN--

IN THAT CASE, I WOULD...



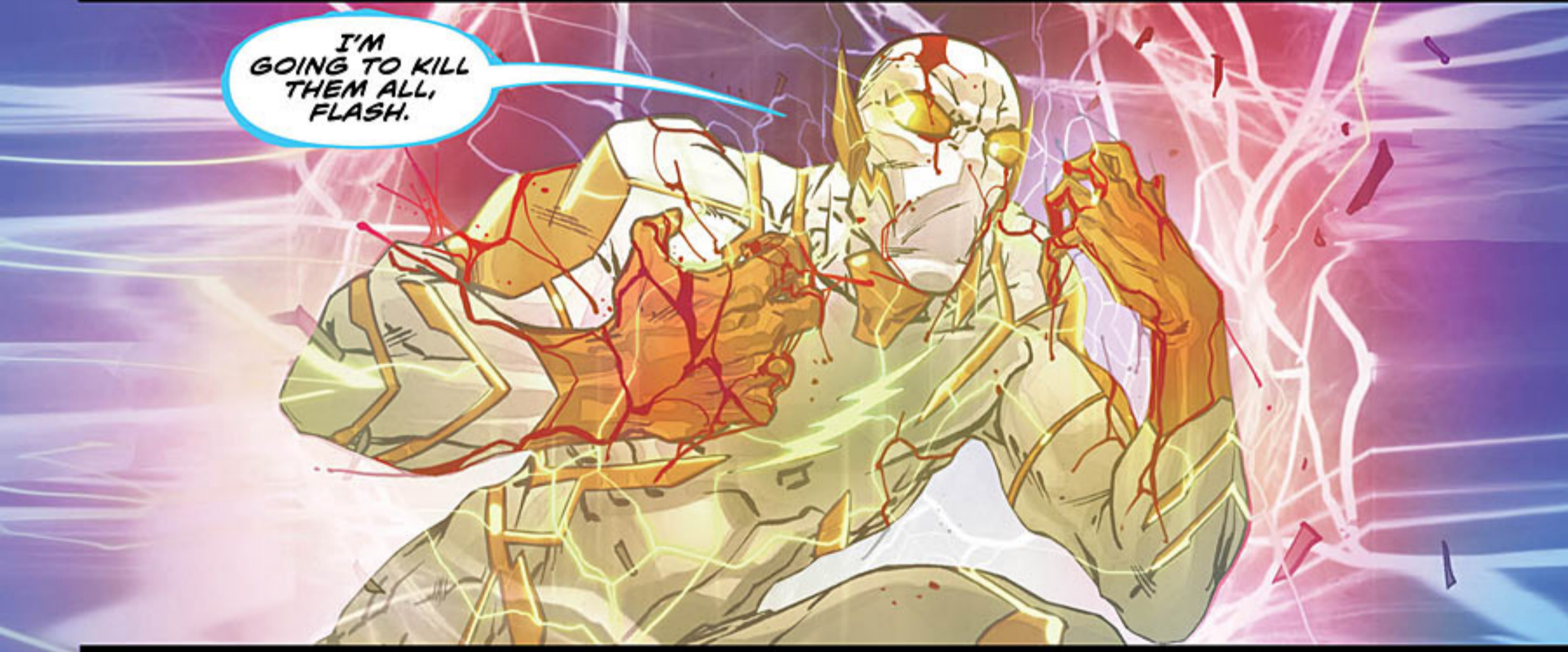

YOU OKAY, ALLEN?

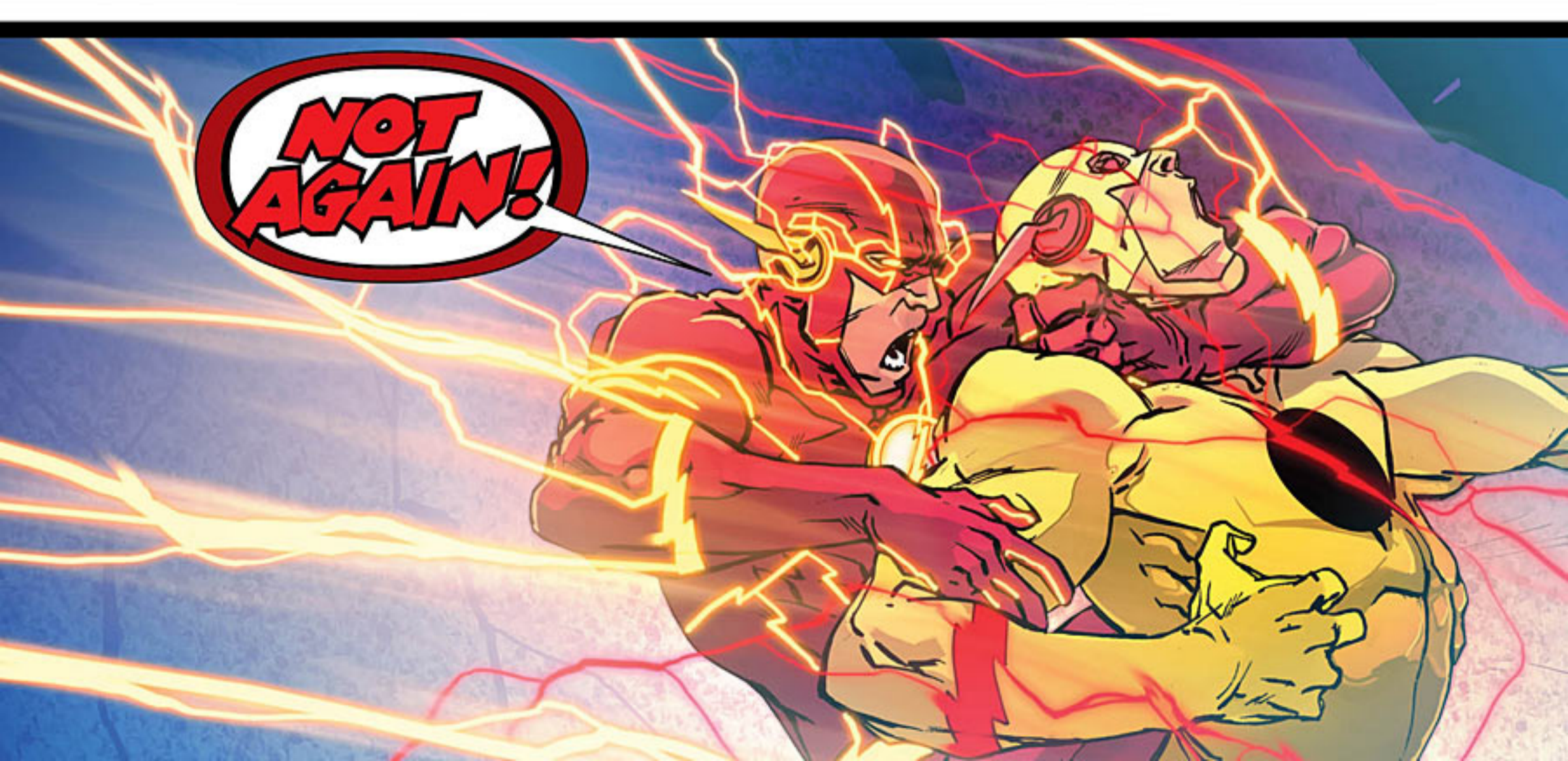


THIS IS WHAT I WAS WORRIED ABOUT.
