

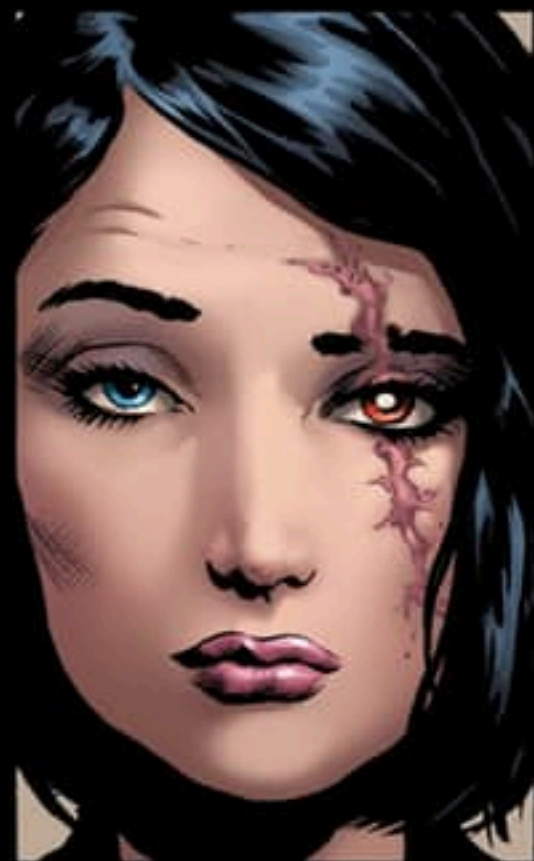




CADULO-
