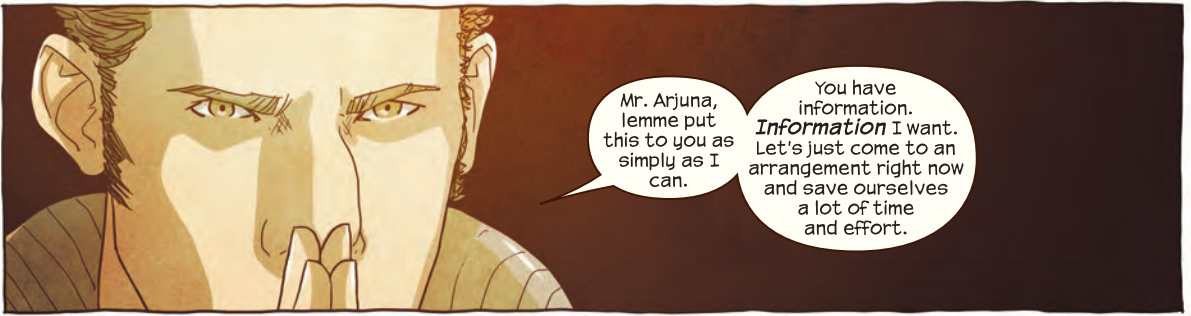

Mr. Arjuna, lemme put this to you as simply as I can.

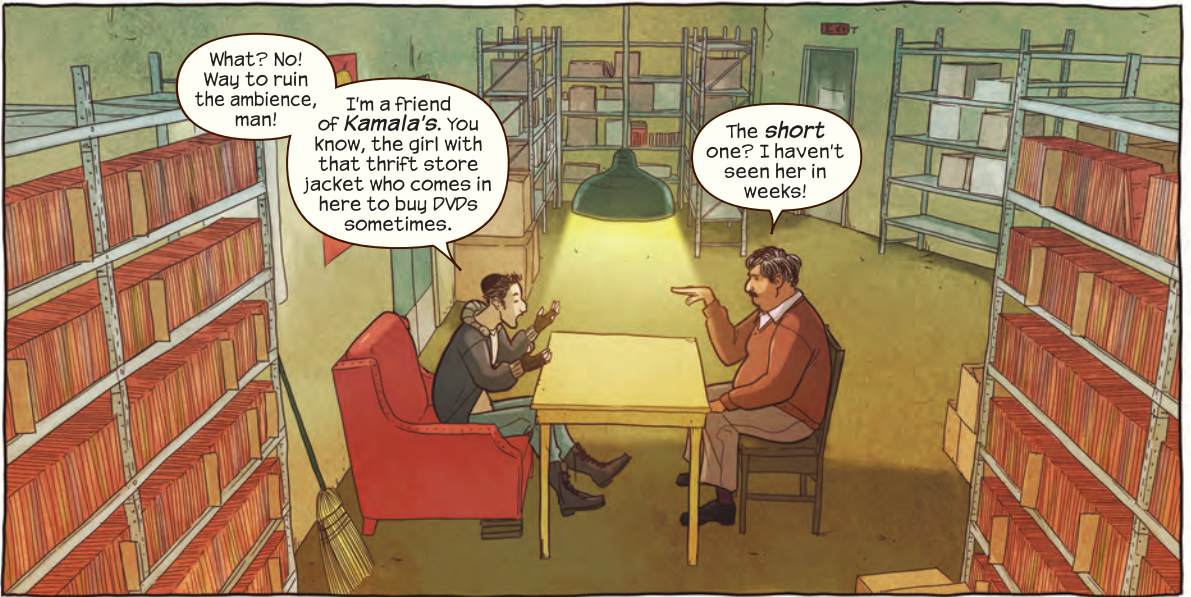
You have information. **Information** I want. Let's just come to an arrangement right now and save ourselves a lot of time and effort.

Okay, okay. Let's back up a little. When you last saw her, did she look *different*?

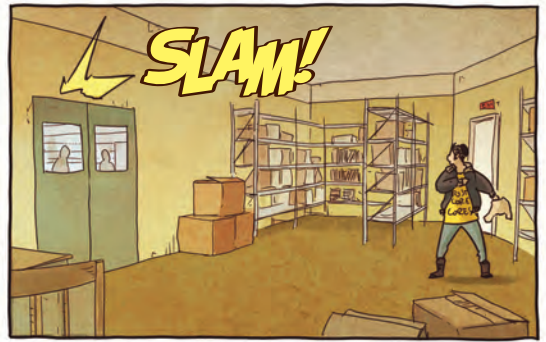
Different?

We've got to be careful. If your friend has been taken captive by this--*Inventor*-- then we must assume he knows we're coming.

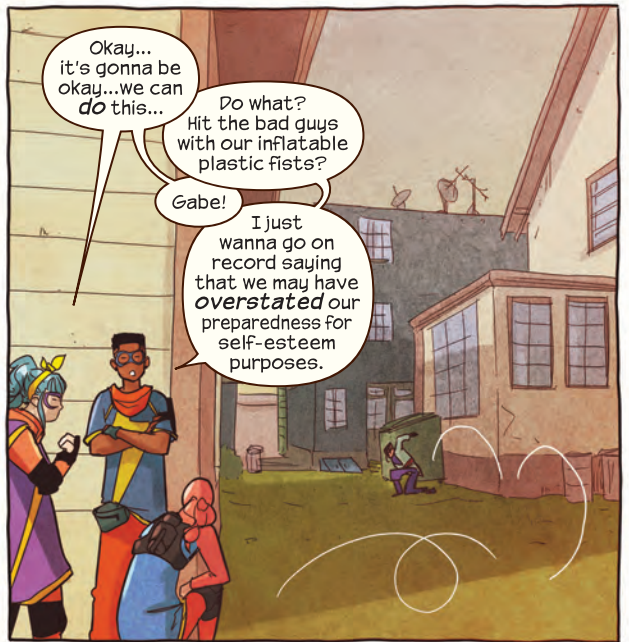
The last time we confronted him, he sent an *exploding dinosaur* after us.
