I KNOW!! I'M POWERS DIVISION!

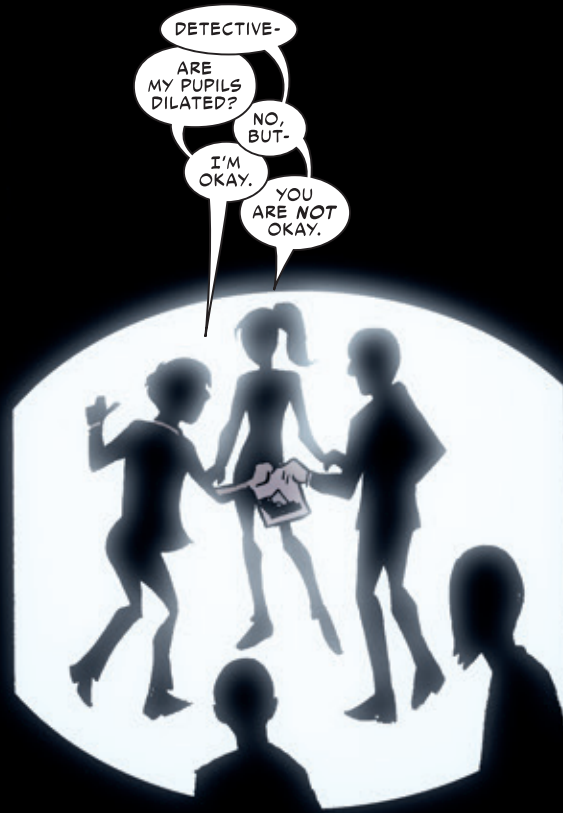


YOU HAVE TO SIT DOWN!!

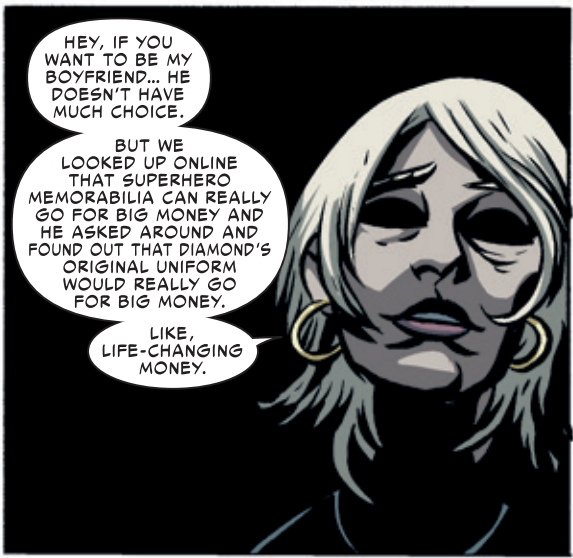
MAYBE THAT'S WHAT HAPPENED- WHATEVER HAPPENED WE ENDED UP BACK AT HIS PLACE.

HE TOLD ME HE USED TO BE DIAMOND. I TOLD MY BOYFRIEND.



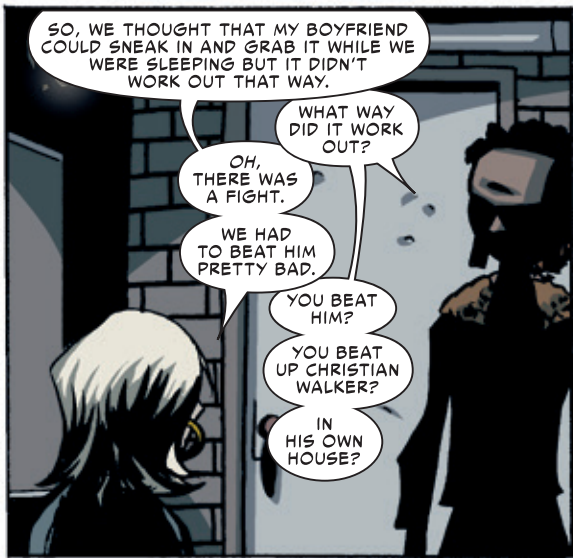
YOU HAVE A BOYFRIEND?
