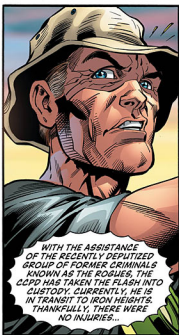
I FINALLY HAVE A BITE!
