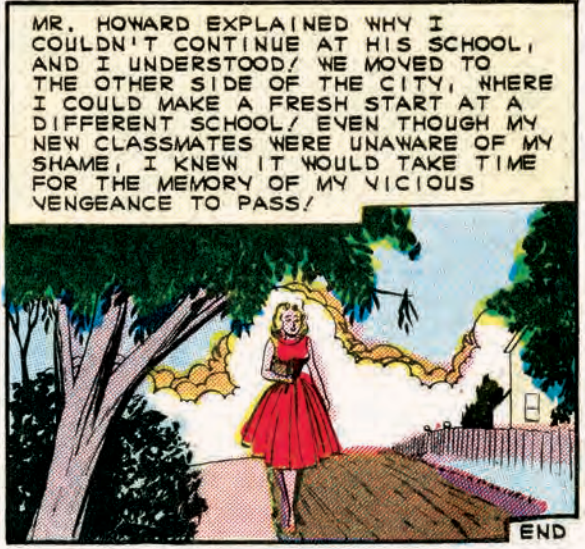
MR. HOWARD'S ROUGH TACTICS FORCED THE TRUTH FROM MY LIPS...
