Alice Roosevelt - Classified by Presidential orders.

Mickey Mantle - Case ID #: 664-NY-6166 Suspected draft dodger, falsified ankle injury to remain stateside and sign professional baseball contract. Disability fraud co-conspirators could include [REDACTED]

JD Salinger - Case ID #: 172-NH-6847 Accused of hiding secret messages in literature, inducing (indulging?) murderous compulsion, investigation pending. Forensic linguistic analysis of all known writing warranted.

Elvis Presley - Case ID #: 346-TN-6641 Accused subversive behavior and lewd conduct, actions and motions on stage were such as to rouse the [REDACTED] Possible connection to Soviet Union attempts to undermine US societal norms and foment misbehavior of American youth leading to breakdown of traditional family values.

Alice Roosevelt - Classified by Presidential orders.

Robert Kennedy - Case ID #: 4268-MA-7811 Current Leader of the Kennedy Family Organized Crime Syndicate. Suspected of extramarital affair with Marilyn Monroe, also subject of FBI investigation. Subversive, anarchist behavior in connection to [REDACTED]

[REDACTED] alcohol abuse likely. Numerous close associations with high ranking members of La Cosa Nostra, particularly those running Chicago. Could be complicit on [REDACTED]

Malcolm Little AKA Malcolm X - Case ID #: 3966-NY-2626 High priority terrorist combatant. Suspected of illegal activity in conjunction with cult group, Nation of Islam (NOI). Source coverage indicates possible weapons stockpiling in several major US cities for purposes of carrying out race war and the violent overthrow of the US Government.

Marion Mitchell Morrison AKA John Wayne - Case ID #: 7721-MA-612 Cultural leader of American anti-Communist efforts. Full protection detail issued by US intelligence community joint task force in conjunction with investigation re: assassination order by Joseph Stalin. Suggest using movies as platforms for subliminal pro-US Government messages.

Neil Armstrong - Case ID #: 612-OH-1088 Suspected [REDACTED] and federalist principles. Continue planting stories hinting US moon landing was faked to undermine his credibility.
