WHAT, LIKE A RASPBERRY? HEH.



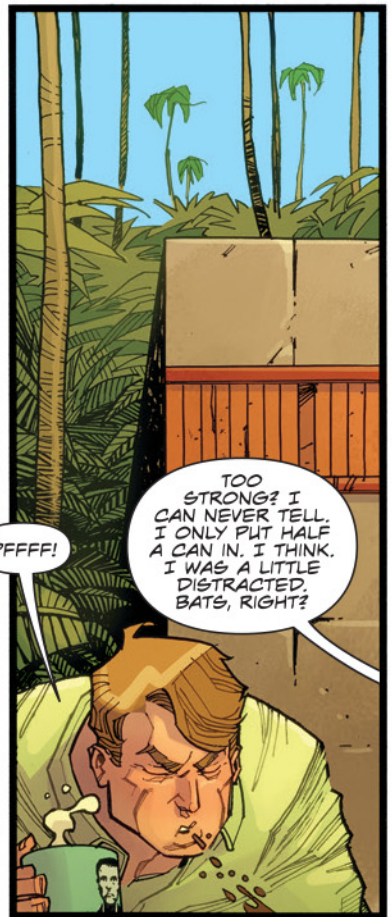


TEN YEARS, FOUR MONTHS, ELEVEN DAYS, AND NINE HOURS. YOU KNOW, MORE OR LESS.

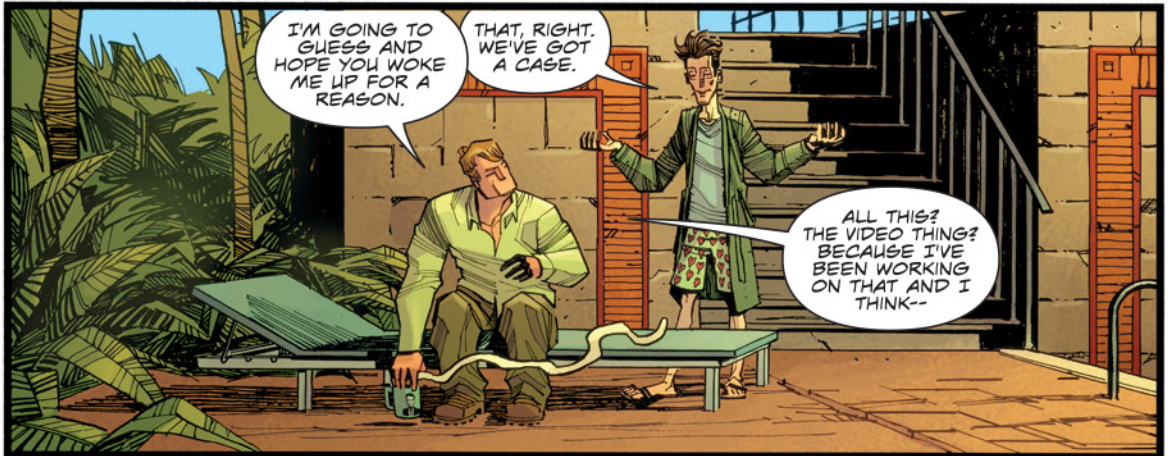
