I didn't-- I never imagined it was *you* under that mask.

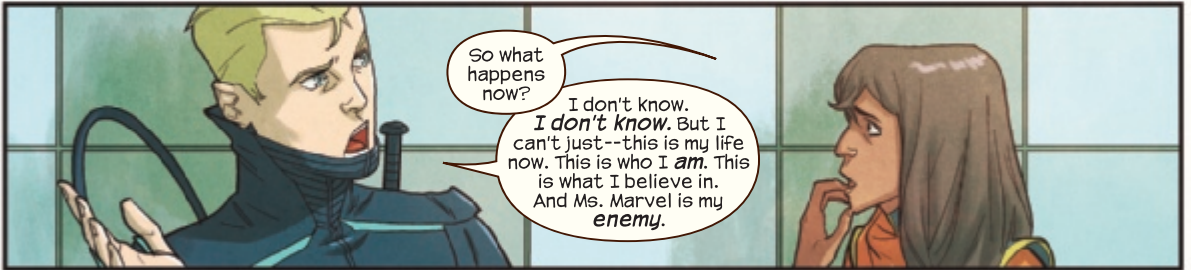
But now that I *know*, I can't give you a pass just because we're friends.
