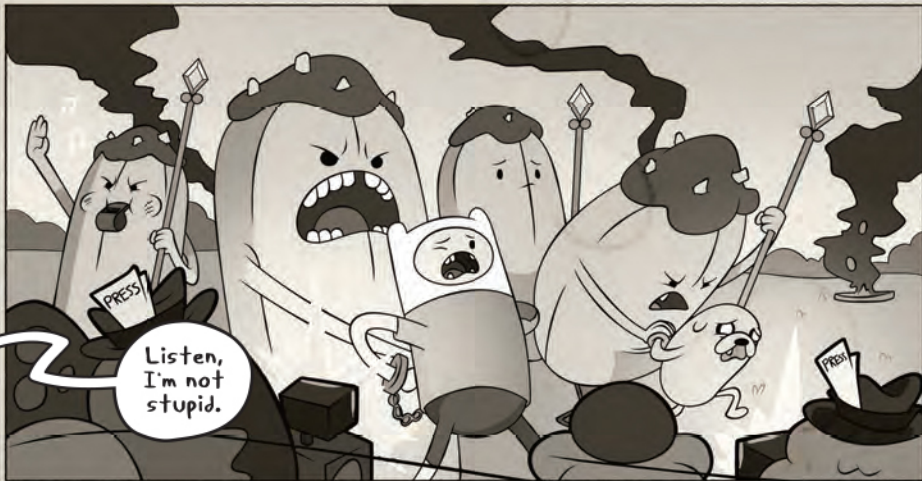

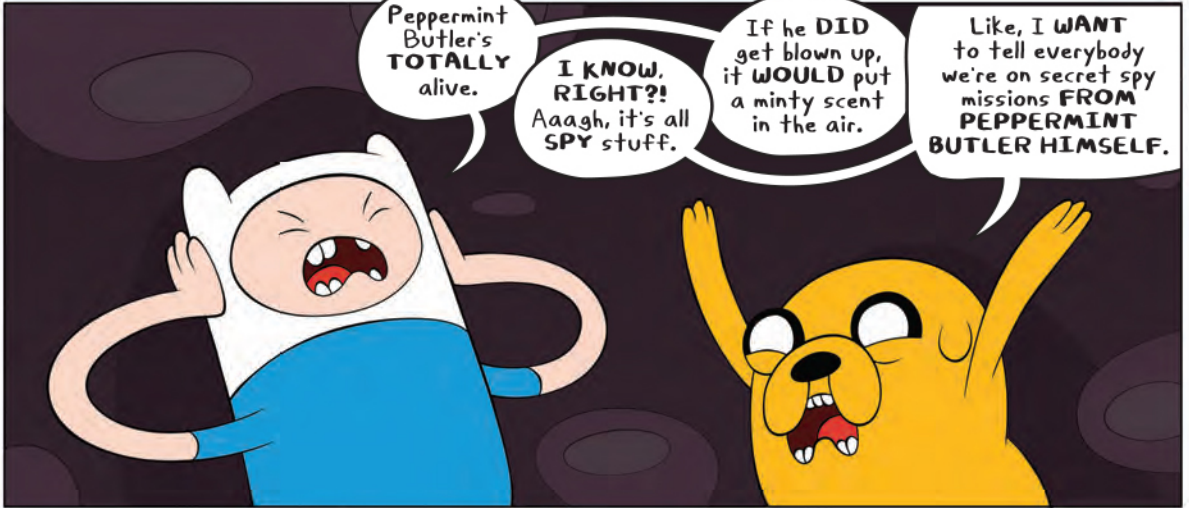


Peppermint Butler's **TOTALLY** alive.

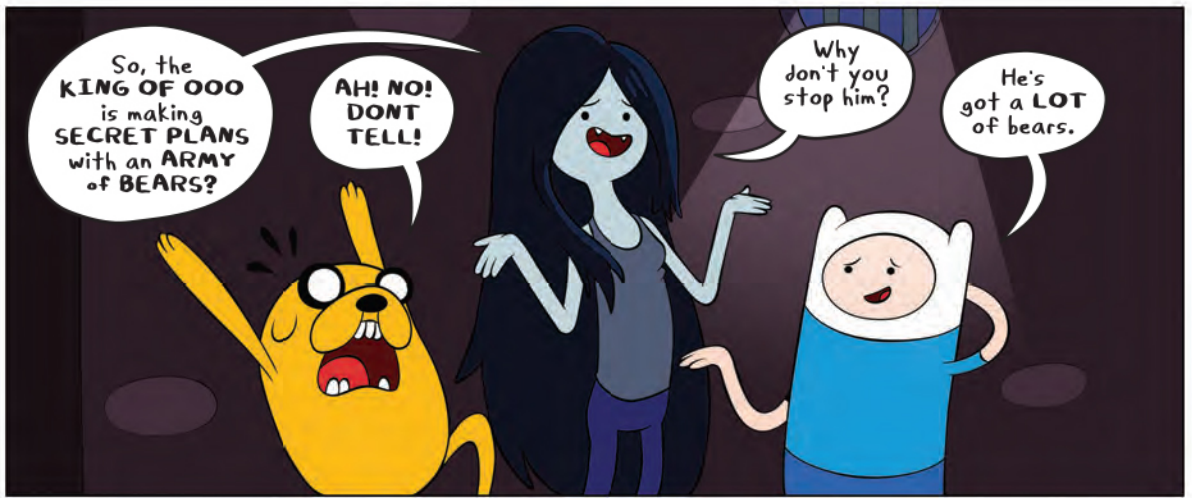

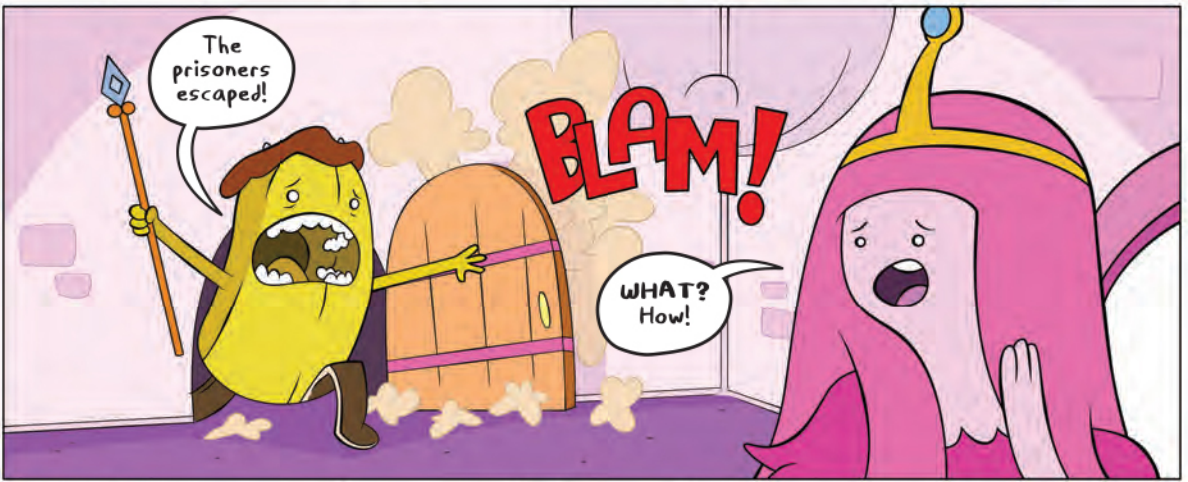
