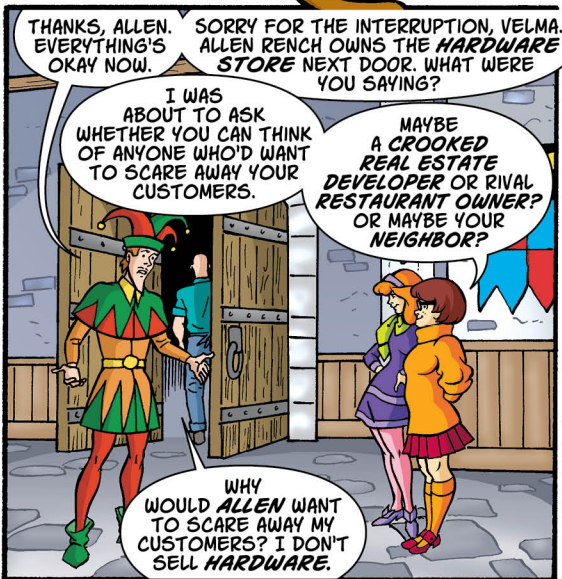

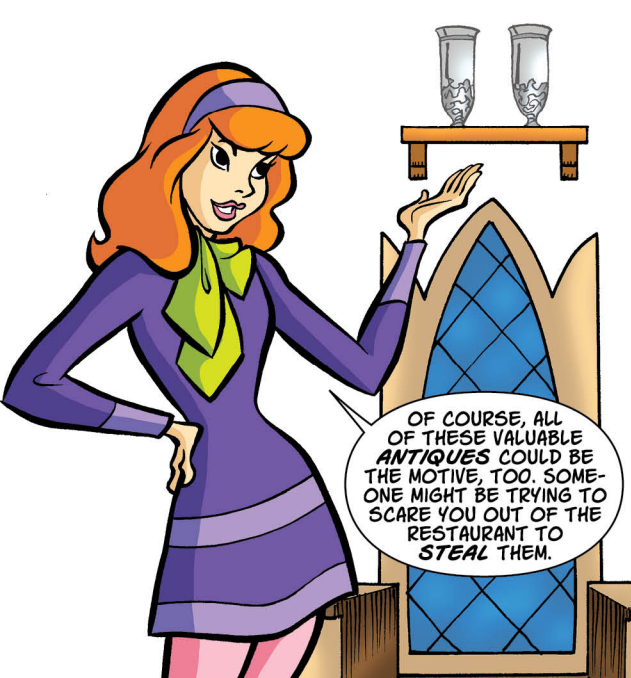

I GUESS. BUT I'D HATE TO THINK THAT SOMEONE WHO WORKS FOR ME COULD BE A THIEF...

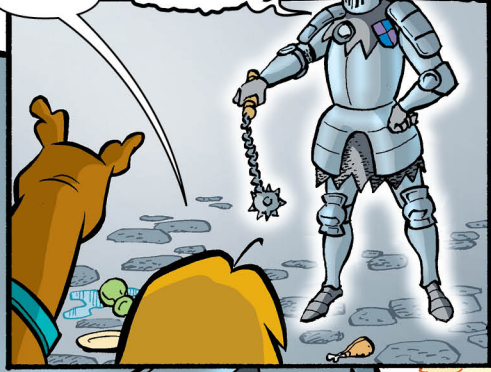

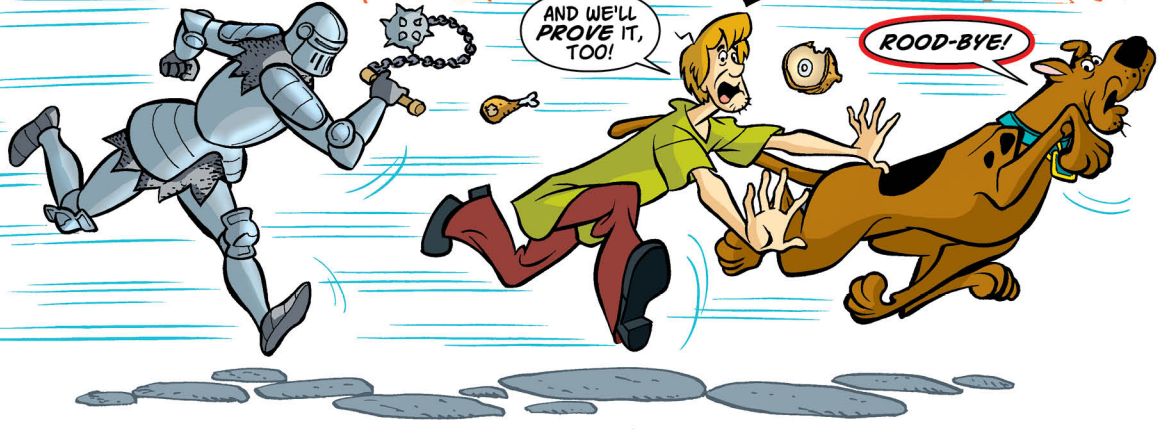
