

I did this strip a few months after this actual incident occurred. The characters were changed to protect the identities of the patient and his mom. As far as I know, they never did see the connection! — LJ




I was contacted by several anti-drinking groups who thought my story was irresponsible. I had to admit they were right—but, on the other hand...aren't we all from time to time? — LJ
