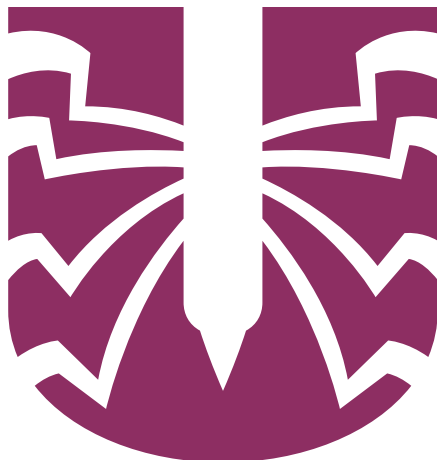

THAT'S WHY I TOSSED THAT CARD HE GAVE ME. (PLUS, Y'KNOW, IT WAS BLANK.)

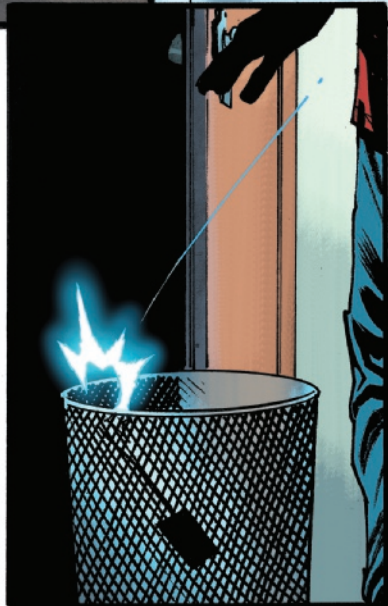
