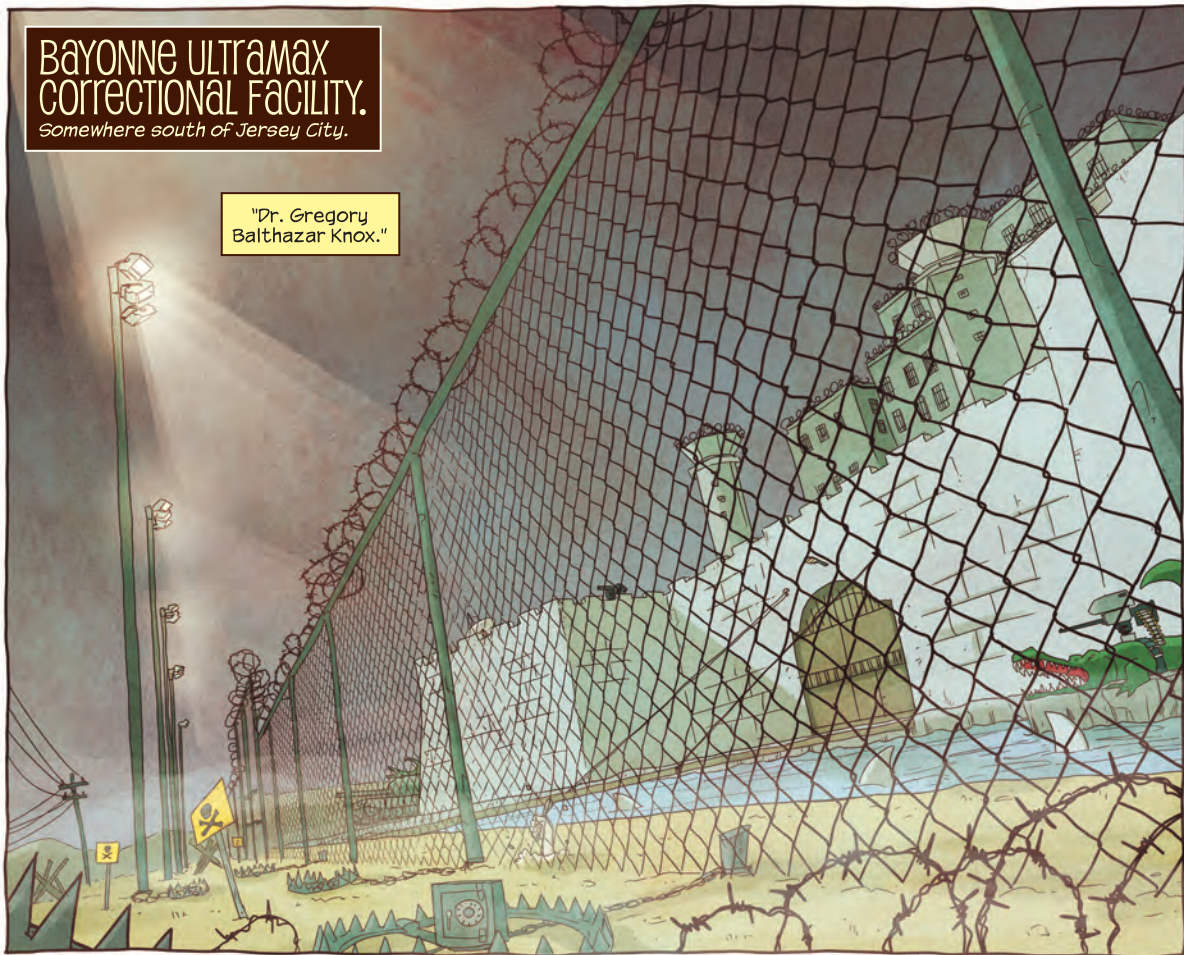

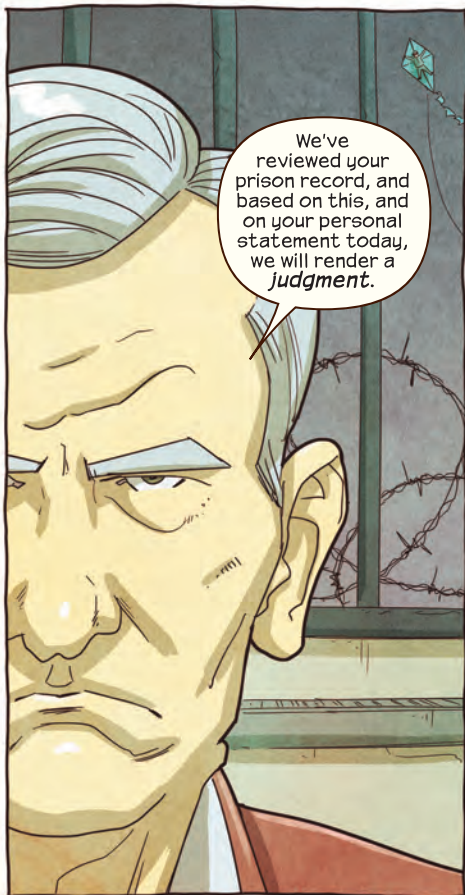

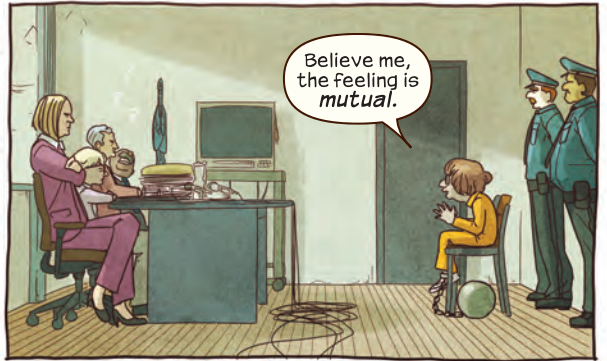
I've learned my lesson. I've paid my debt to society and I am ready to be a productive citizen.

That's what I'm supposed to say, isn't it?

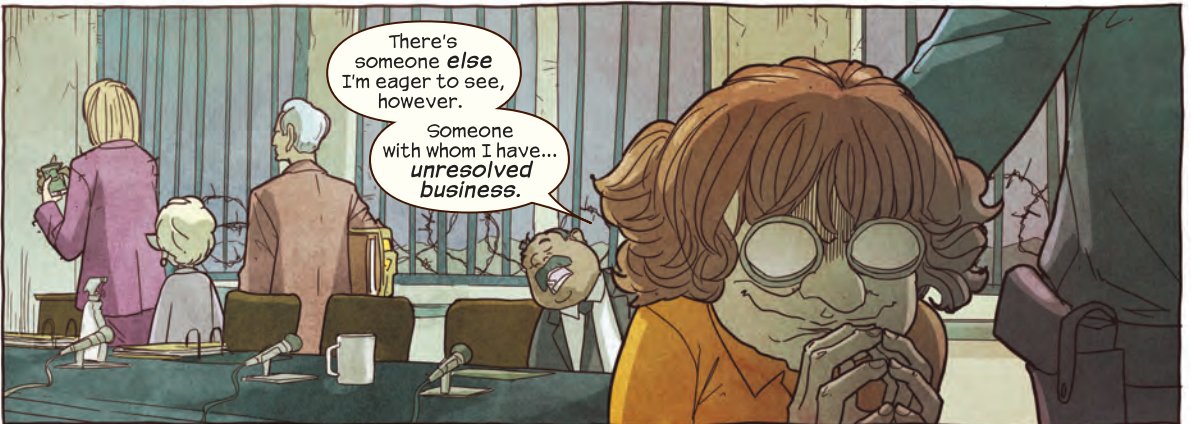
